The Data Risk Check is our approach to discovering and reporting on dark data compliance risks, and is the core activity of the Compliance Workshop Data Risk Management. The activity is spread out over several weeks to allow time to run on top of your Cloud infrastructure and surface compliance risks in organisational data.

Data Risk Check leverages automated Microsoft 365 tools and services to discover data stored in the Microsoft Cloud and identify potential problem areas. The automated discovery process will analyse your existing data for:



Sensitive information and intellectual property

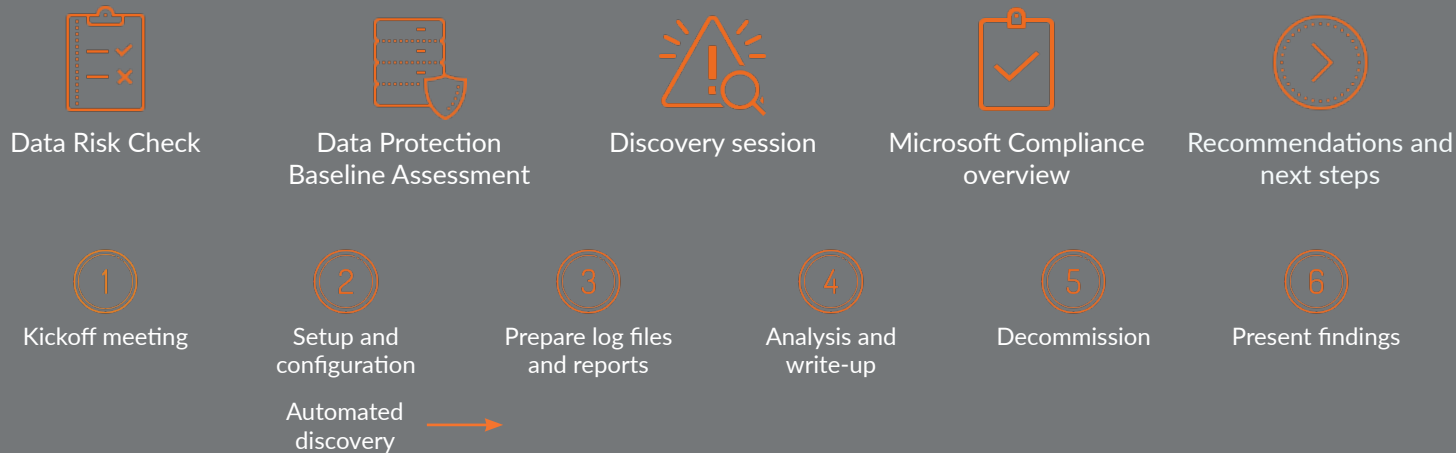


Unused or "stale" data
